INTRODUCTORY PROVISIONS

WHEREAS, the Declaration of Covenants and Restrictions for Glenwyck Farms, Westlake, Texas, was filed of record on April 20, 2000, and is recorded as Document No. D200083227 in the Official Public Records of Tarrant County, Texas (the "*Declaration*"); and

WHEREAS, the Declaration affects certain tracts or parcels of real property located in Tarrant County, Texas, more particularly described on Exhibit "A" attached hereto (the "*Property*"); and

WHEREAS, pursuant to Section 209.0041 of the Texas Property Code, the Declaration may be amended for any purpose by a vote of sixty-seven (67%) of the total votes allocated to property owners entitled to vote on the amendment to the Declaration; and

WHEREAS, attached hereto as Exhibit "B" are the acknowledged signatures of Owners representing no less than sixty-seven (67%) of the total votes allocated to property owners entitled to vote on this amendment to the Declaration, as set forth below with specificity, evidencing the requisite approval of the amendment to the Declaration as required by Section 209.0041 of the

Texas Property Code.

NOW, THEREFORE, the Declaration is hereby amended as follows:

(A) Section 10.01 of Article X of the Declaration is hereby amended to read, in its entirety, as follows:

Section 10.01 These Covenants may be amended from time to time for any purpose by a vote of sixty-seven percent (67%) of the total votes allocated to the Association as set forth in Article IV, Section 4.02 hereof. Votes may be cast in person or by proxy at a meeting of the Association, by absentee ballot, by electronic ballot, or a combination thereof, as such voting methods are described in Section 209.00592 of the Texas Property Code, as amended or set forth in any successor statute.

The effect of this First Amendment to the Declaration shall be prospective only and shall not serve to impair any vested rights of an Owner as of the date this First Amendment to the Declaration is filed of record. The terms and provisions of the Declaration, except as modified herein, are hereby declared to be in full force and effect with respect to the Property. The Property shall continue to be held, occupied, sold and conveyed subject to the terms and conditions of the Declaration and now this First Amendment to the Declaration.

IN WITNESS WHEREOF, this First Amendment to the Declaration, having been executed by a duly authorized representative of the Association, is to be effective upon its filing with the office of the Tarrant County Clerk.
